## Cambridge–Hitachi Primary Software Collection Purchase Agreement

### 1. Scope of Agreement

**1.1** By signing and returning this Agreement to Cambridge–Hitachi at the address given above you are indicating that You wish to purchase the complete set of CD-ROMs ('the Product') specified on the accompanying order form subject to the terms and conditions stipulated below.

**1.2** This Agreement is subject to the Terms and Conditions of Use in each CD-ROM, forming part of the Product. It is important that You read the Terms and Conditions of Use for each CD-ROM before installation.

**1.3** If after receiving the Product You do not wish to keep the Product You shall be able to return it to Cambridge–Hitachi for a full refund. However, the Product must be returned within 30 days of the day on which You received it in order to qualify for the refund. All CD-ROMs in the Product must be returned to Cambridge–Hitachi before a refund can be given.

Retaining any or all of the CD-ROMs will constitute a purchase and a refund will not be issued. In the event of the Product being returned, this Agreement will be considered terminated and the payment stipulated below will no longer apply.

**1.4** You shall not be permitted to sell or provide free of charge all of any part of the Product to any other individual or educational establishment in the event that You do not require all the CD-ROMs in the Product.

**1.5** Use of the Product is restricted solely to use in the United Kingdom and use of the Product outside this territory is expressly prohibited.

### 2. Ownership of Copyright

**2.1** The Product (including any images, photographs, animations, video, audio, music and text incorporated into any of the CD-ROMs) is owned by Cambridge–Hitachi, or its suppliers or licensors, and is protected by the copyright laws of England and international treaty provisions.

**2.2** You may not copy any or all of the Product except for making one copy of each CD-ROM solely for backup or archival purposes. You may not alter, remove or destroy any copyright notice or other material placed on or with this CD-ROM.

**2.3** You shall ensure that use of the Product does not infringe the copyright, moral rights, patent or other intellectual property rights of any person.

### 3. Fee

You shall pay Cambridge–Hitachi the total fee (£1,500, or £2,250, or £2,985 as indicated at the head of this Agreement) in three equal instalments as follows: Instalment 1 following receipt of an invoice following signature of this Agreement (usually within 30 days); Instalment 2 at the end of the first year of this Agreement; and Instalment 3 at the end of the second year of this Agreement. Cambridge–Hitachi shall invoice you for Instalments 2 and 3 in advance of the end of the first and second years respectively.

### 4. Termination

Without prejudice to any other rights, Cambridge–Hitachi may terminate this Agreement if You fail to comply with the terms and conditions of this Agreement or the individual Terms and Conditions of Use applying to each CD-ROM. In such event, You must destroy all copies of the CD-ROMs in your possession.

### 5. Jurisdiction

This Agreement shall be governed by the laws of England.
